Order Under Section 38 of the Competition Act.

The Commission considered an application under section 38 filed by the informant for rectification to the order dated 10.4.2013. It is submitted in the application that cause title appears in the said order “KEERTHY KRISHNAN & ORS VERSUS BHARAT PETROLEUM CORPORATION LIMITED AND OTHERS” whereas in the information filed by the informant it was appearing as “KEERTHY TRAVELS & ORS VERSUS BHARAT PETROLEUM CORPORATION LIMITED AND OTHERS”.

2. The Commission perused the record and found that the information was filed by KEERTHY TRAVELS & ORS not by the KEERTHY KRISHNAN therefore, there is an error apparent in the cause title in the order dated 10.4.2013 passed under section 26 (2). Accordingly, the Commission decided to rectify the cause title of the case in the order dated 10.4.2013 as:

KEERTHY TRAVELS & ORS- Informant
and

Bharat Petroleum Corporation Limited (BPCL) Mumbai OP-1

Regional LPG Manager (South) BPCL, Chennai OP-2

Territory Manager, BPCL, LPG filling Plant Kochi Refinery OP-3

Territory Manager, BPCL, LPG Bottling Plant Coimbatore OP-4

(collectively 'Opposite Parties')

3. The order dated 10.4.2013 shall therefore, stand rectified to the above extent.

4. The Secretary is directed to communicate the informant, accordingly.
