- A. **"Fair Play"**: 9th, 10th and 11th Editions of Quarterly News letter "Fair Play" have been published and distributed among various stakeholders
- B. **ICN Merger Workshop 2014:** During 1 2 December 2014 ICN Merger Workshop 2014 was hosted by the Competition Commission of India under the auspices of International Competition Network. During the two-day Workshop, discussions focused on the role of international cooperation in merger enforcement. The workshop took stock of the extant mechanism for international cooperation between competition agencies in merger enforcement and deliberated on building an effective framework for international cooperation in the areas of merger remedies, and outreach initiatives in the context of merger control. Besides, various competitions jurisdictions mutually shared experiences and success stories that motivated participants.
- C. **Booklet in the Advocacy Series**: As a part of the Advocacy Series, one more Booklet on 'Provisions relating to Public Procurement' was published for the benefit of the stakeholders
- D. **'Competition Tracker -2013'**, a compendium of the Orders of CCI (in 2 volumes), containing the decisions given under Section 26(2), 26(6), 26(7), 27 and 31 (1) of the Competition Act, during the period from January December 2013, has been published in two volumes and was released by the Hon'ble Minister during the Workshop.
- E. **Annual Day**: CCI celebrated its 5th Annual Day (the day of commencement of the Act) on 20th May 2014. Dr. Raghuram Rajan, the Governor of Reserve Bank graced the occasion as the Chief Guest, delivered a lecture on "Competition in the Banking Sector: Opportunities and Challenges" and released seven Advocacy Booklets brought out by the Commission.
- F. **Internship**: As a part of Advocacy with Students who are important stakeholders, CCI provided internship to students from the streams of Law, Economics etc. During the period 79 students interned with CCI on various subjects and topics of Competition Law.
