Accordingly, this notice is being filed under the provisions of Section 6(2) of the Competition Act, 2002 ("Competition Act") and pertains to a simultaneous merger and demerger under the provisions of Section 5(c) of the Competition Act.

Chalet:

Chalet is engaged in the business of leasing commercial office space ("COS Business"), the hotel business, the retail business and the business of real estate development.

Genext is engaged in the hotel business, the mall retail business,

financing activities and the business of real estate development.
