Notice inviting tender for Civil and Electrical Works in CCI Regional Office at Chennai

Competition Commission of India (CCI) intends to engage an agency/contractor for carrying out Civil and Electrical Works in its Regional Office (South), Chennai having address at No.652, BSNL Exchange Building, Nandanam, Chennai – 600035. The estimated value of the works will be Rs.13.8 lakhs approximately.

2. Scope of work:

Scope of the work with layout drawings is mentioned at **Annexure-** II of this bid document (enclosed herein)

3. Eligibility:

Contractors having experience of successfully executed/completed at least one single order of 80% of the Estimated Value of the works, or two works each of 50% of the Estimated Value of the works or three orders each of 40 % of the Estimated Value of the works, of similar nature in the last three years to any Central/State Government Organizations/Offices/PSU/Public Limited Companies are eligible to participate in the bidding. The agency/contractor must have registered office address in Chennai.

- 4. **Submission of Tender**: The tender is a Two Bid system and the interested agencies/contractors are required to submit their tender in two separate envelops in the manner explained at Para 24 of this tender notice. **Sealed tenders complete in all respect must be submitted latest by 26 November 2021 upto 12.00 PM in the Tender Box placed at the Reception of Regional Office (South), No.652, BSNL Exchange Building, Nandanam, Chennai 600035 Tamilnadu. The Technical Bids shall be opened by the Standing Committee constituted by CCI for the purpose or by the officers nominated by the Committee on the same day. The date and time of opening of Financial Bids will be informed after evaluating the Technical Bids by the Standing Committee appointed for this purpose. The Financial Bids of only those agencies/contracts who have qualified the eligibility criteria of 'Technical Bids' as stipulated in the tender document shall be opened. Incomplete & conditional tenders and tenders received without EMD shall be summarily rejected. The CCI reserves the right to reject any or all the tenders without assigning any reason thereof.**
- 5. A Pre Bid Meeting will be held on 15 November 2021 at 04.00 PM in Regional Office (South), Chennai at No.652, BSNL Exchange Building, Nandanam, Chennai 600035. with

a view to familiarise the prospective agencies/contracts with the requirement of the office/scope of work and address the related doubts, if any. The bidders can also physically inspect the work premises during working hours on any working day and ensure the quantity and scope of the work before bidding.

5. Tender must be submitted on the Tender documents issued by CCI/downloaded from the website of CCI i.e. <a href="www.cci.gov.in under "what's New". Submission of tender by FAX/Mail is not acceptable.

- 6. Omission, neglect or failure on the part of the bidder to obtain requisite reliable and full information on any matter affecting his/her tender, shall not relieve the bidder, from any liability of successful completion of the work as per the scope of work.
- 7. Scope of work: The bidders are requested to go through the 'Scope of Work' and layout drawings given at Annexure -II and 'Terms and conditions' of the bid before submitting their offer/bid. Any clarification, if required, may be obtained prior to filling of bid from the CCI, Regional Office Chennai or during pre-bid meeting. No claim whatsoever on such account shall be entertained by the CCI in any circumstances.
- 8. <u>Earnest Money Deposit (EMD)</u>: The bidder shall furnish a Bid Security Declaration as per the format provided in the Annexure V Performance Security
- 9. Performance Security: The agencies/contractors selected for the work shall deposit Performance Security equivalent to ____2_% of the total work value in the form of Fixed Deposits/Online Payment favoring "Competition Commission of India. The successful bidder should furnish Performance Security at the time of accepting the work order. The Performance Security shall be released by CCI after successful and satisfactory completion of the assigned work, without interest and subject to the conditions that no losses are incurred to the CCI due to the agency/Contractor or their employees and all statutory dues have been cleared.
- 10. The bidders should sign all the pages with seal and submit acceptance for terms and conditions of the bid as stipulated. The bid submitted without the acceptance of the terms and conditions shall be summarily rejected.
- 11. CCI reserves the right to accept or reject any or all bids in part or in total without assigning any reason thereof.

12. Rate / Price

- (a) The bidders are required to quote total prices for (i) Civil Works and (ii) Electrical works separately. Combined lowest price quoted for both Civil and Electrical works will be declared as L1 bidder.
- (b) The price to be quoted shall remain firm without the price variation clause. The bidders should not claim for any price variation / escalation after award of the work.
- (c) The bid submitted with a price variation/escalation clause will be rejected.
- (d) Bid / price quoted by the bidder shall remain valid for 90 days from the date of opening of the tender for the purpose of acceptance and award of work; validity beyond 90 days from the date of opening shall be by mutual consent. No price variation / cost escalation is accepted.
- (e) The prices quoted by the bidder should be inclusive of transportation charges, insurance, Labour cost and any other statutory levies etc. GST should be mentioned separately.
- (f) The price bid should be placed in a separate sealed cover and price bids attached with technical bid in open way will be rejected.

13.. Execution of work:

- i. Time period of completion: The successful bidder shall execute and complete the work as per specification/Scope of work mentioned in Annexure-II to the satisfaction of the CCI within a period of 30 days from the date of award of work. The successful bidder shall not sub-contract the work in whole or in part to any entity.
- ii. The successful bidder to whom the work is awarded shall have to execute the work as per the work order and the terms & conditions of this tender document.
- iii. The CCI will not be responsible for the loss, breakage/damage of any goods during the transit.
- iv. No extra cost at any stage shall be given for transportation; cost of laborer, insurance etc., as the rates quoted is all inclusive price.
- v. The contractor should bring all the supporting materials and logistics for carrying out the work.

14. Variation in quantity / scope of work:

The quantity mentioned in the scope of work/layout drawings is approximate. Bidders are requested to visit the site for verifying actual the quantity and familiarize

15. Penalty for Delay in completion of work

As mentioned in Para 13 the work in all respect should be completed within a period of 30 days from the date of issue of work order. For delay in completion of work beyond 30 days, a penalty of @ 1% of order value per week or part thereof, subject to the maximum of 3% of the order value shall be deducted, beyond which, entire Performance Security Performance Security will be forfeited.

16. Extension of work completion time

Except for Force Majeure normally no time extension shall be granted. However, CCI reserves the right accept/reject request for extension of time limit for completion of work, if any from the successful bidder.

17. Work Completion Certificate

The successful bidder is required to submit a work completion certificate to CCI within 1 week of completion of the work for inspection by CCI and issue of successful work completion certificate by CCI for facilitation of payment process. The work must be completed in all respects and after completion the site must be cleared and cleaned.

18. Payment terms

No advance payment will be made. 90% of total payment shall be made against the final bill within 30 days from the date of completion of the work to the satisfaction of CCI and issue of satisfactory work completion certificate by CCI. 10% of total payment amount shall be withheld for a period of six months as defect liability and for defective work corrections, if any during the period.

19. Guarantee Period

Guarantee period should be six months from the date of completion of the works against poor workmanship, poor performance, and in case of deficiencies are found during guarantee period, the same shall be rectified free of cost by the agency/Contractor at their own cost and risk.

20. Quality assurance:

The successful agency/contractor should ensure the quality of material and as per the BIS/ISI Standards wherever make of the materials are not specified.

21. Right to accept or reject tender:

CCI does not bind itself to accept the Lowest bid or to give any reasons for its decisions. The CCI reserves the right to reject any or all of the tenders received without assigning any reason thereof.

22. Safety Regulations:

- (i) The agency/Contractor shall take necessary safety measures and it will be solely responsible for the safety of the laborers/workers engaged by them. CCI will not be responsible for any loss of life/injury caused during performance of the duty by the laborers/workers Compensation/expenditure on treatment on such loss of life/injury will be the sole responsibility of the agency/contractors.
- (ii) Logistic Items/infrastructure to carry out the civil/electrical works as specified in the bid should be arranged by the successful bidder. CCI will not provide any materials or manpower at any stage.

23. Evaluation Criteria:

Combined lowest total of the prices quoted for (i) Civil work and (ii) Electrical work will be selected as L1 bidder and awarded the work

24. Submission of Tender:

- (i) The tender is a Two Bid Tender, the technical bid as per the format prescribed in Annexure III and Financial Bid in the format as prescribed in the Annexure IV must be submitted in separate covers. The cover containing financial bid must be sealed.
- (ii) The technical bid alongwith Demand Draft for EMD to be put in a one envelop, and financial bid shall be placed in a second sealed envelope. Both the envelopes should be placed in one sealed envelope superscribed "Tender for Civil and Electrical works" at SRO (C) and must be dropped in the Tender Box kept at reception of the O/o Competition Commission of India, Southern Regional Office, Chennai, BSNL Exchange Building, No.652, Anna Salai, Chennai 600035 on or before 26th November, 2021 till 12:00 PM.
- (iii) A pre-bid meeting will be held on 15th November, 2021 at 04:00 PM in the reception of the O/o Competition Commission of India, Regional Office-South, BSNL Exchange Building, No.652, Anna Salai, Chennai 600035, Tamilnadu.
- (iv) Financial bids of only those bidders who qualify in the technical bids shall be opened.
- (v) Late/delayed submitted tenders due to any reason, whatsoever will not be accepted/considered, at all under any circumstances.
- (vi) The tender shall remain open for acceptance for a period of 90 (Ninety) days from the date of opening of the tender
- 25. The successful contractor/agency should indemnify/keep indemnified and hold CCI harmless from any liability claim, demands for damages caused by contractor/agency to a third part asset due to commission or omission by the act of contractor/agency during the execution of work.

- 26. CCI does not bind itself to accept the Lowest bid or to give any reasons for its decisions. The CCI reserves the right to reject any or all of the tenders received without assigning any reason thereof.
- 27. The agency/contractor should not be blacklisted of the firm by any Government Department/PSUs/Autonomous Organization etc. A certificate should be submitted by the agency/contractor to this effect alongwith the technical bid.
- 28. Except as otherwise provided elsewhere in the Tender document, if any dispute, hereinafter arises between the Parties, which cannot be mutually resolved, shall be settled in accordance with the provisions of Arbitration and Conciliation Act, 1996 (as amended from time to time).


