TERMS AND CONDITIONS

1. The bidders are required to deposit Earnest Money of Rs.2,000/- by way of Demand Draft drawn in favour of Competition Commission of India (Competition Fund) Account. Bids received without EMD will not be considered and stands rejected.
2. EMD will be released to the successful bidder only on receipt of the documents relating to transfer of the vehicle in his/their name.
3. All formalities regarding transfer of vehicle in his/their name will be completed by the successful bidders within one month of delivery of vehicle.
4. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her/their name at his/their own cost. CCI will not be responsible for any lapse on his/their part in this regard.
5. The successful bidder is required to deposit the full amount by way of Demand Draft drawn in favour of Competition Commission of India (Competition Fund) Account within three days of the acceptance of the bid.
6. The delivery of the vehicle is subject to the submission of documentary evidence by the successful bidder in support of residential status (Ration Card, Voters Identity Card, Passport, Certificate in case of firms etc.).
7. The sold vehicle will be removed by the successful bidder from the premises of Competition Commission of India within three days.
8. The vehicle will be sold on "as is where is basis" and no guarantee for its worthiness or quality will be given by CCI.
9. All bids shall be valid for minimum of 60 days, from the date of bid opening.
10. The bidders will not be allowed to withdraw his/their bids.
