The terms and conditions for execution of work have been indicated in Annexure-D.

Sealed tenders complete in all respect must be submitted latest by **29.12.2014 upto 3:00 PM**. The bids shall be opened on the same day at 3:30 PM. Incomplete & conditional tenders shall be summarily rejected. The access control system to be installed at HT House shall be compatible with the existing system already installed. CCI reserves the right to reject any or all the tenders without assigning any reason thereof.

Terms and Conditions

1. Cutting/overwriting in Annexure-B & C should be avoided. In case of any cutting/overwriting, the same must be initialed/authenticated.
2. The work must be executed as per the specifications and best engineering practices.
3. Rates are to be quoted on the prescribed format.
4. CCI reserves the right to change the quantity of items required. Any item can be deleted if not required as per site condition. Payment of cable shall be made on the basis of the actual use/measurements.
5. CCI reserves the right to award the work to different bidders for installation of Access Control System in its offices at HT House and Bhikaji Cama Place.
6. CCI does not bind itself to accept the Lower-bid or to give any reasons for its decisions.
7. The agency shall be bound to complete the work within 15 days from the date of issue of the work order.
8. The equipments /products installed must be guaranteed for a period of one year from the date of completion.
9. The agency shall be liable to take care of any faults/defects in the door access control system within a period of one year without any charges. Any such defects shall be rectified within a period of 48 hours from the time of reporting of the defect failing which a penalty of Rs.200.00 per day for the first 2 days and thereafter Rs.500.00 per day shall be payable.
10. The agency selected for the work shall deposit a performance guarantee equivalent to 10% of the total value of the work. The performance guarantee shall be valid at least for a period of one year. It can be submitted in the form of the Bank Guarantee. The performance guarantee will be released by CCI after the period of one year is over.
11. The agency shall submit all the guarantee cards/Brochures to CCI.
12. All materials brought to site shall be as per the technical specifications of the items. In case of any unapproved material is used, the same shall be removed by the agency at his own expense and the same shall be replaced with the item of requisite specification.
13. The payment will be released within 2 week's time after submission of bill as well as performance guarantee.
14. The safety & security of the equipments/products after its installation shall rest with CCI.
15. In case of any dispute, CCI shall have the right to appoint an Arbitrator whose decision shall be final & binding on both the parties.
