Engagement of IT Experts in the Competition Commission of India on contract basis.

2. Experts are required initially for a period of one year which can be further extended as per requirements. He/She will assist the Commission in discharge of its functions under the Competition Act, 2002 and undertake such work/tasks as may be assigned to him/her from time to time. Applicants having following technical know-how, skill sets and experience may apply:

- Knowledge of Software Development & Project Management
- Thorough knowledge in LAN/WAN design development.
- Skills in development of web based application and maintenance
- Skills for development of e-filing portal.
- Skills in Database design and development.
- Administrative and Technical expertise in service delivery.

3. Applicants for engagement as Expert (Level-III) should have qualification of B Tech (Information Technology/ Computer Science)/MCA/Masters Degree in Information Technology/Software System/Computer Science/M Sc (Mathematics). The applicant for engagement as Expert (Level-III) must have mandatory experience of 5 to 10 years in the field of Information Technology in Govt. of India having technical knowhow and skill sets in para 2 above. Applicants for engagement as Expert (Level-I & II) should have qualification of B Tech (IT/Computer Science)/MCA or equivalent. The details of eligibility criteria, remuneration payable and experience are given in the Annexure.

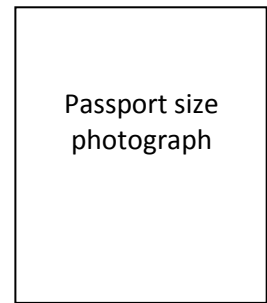
