The appointment will be made on deputation basis initially for a period of 3 years which can be extended upto 5 years and will be governed by the terms and conditions prescribed by the Department of Personnel and Training, Government of India vide OM Number 6/8/2009-Estt.(Pay II) dated 17.06.2010, as amended from time to time. The maximum age limit for appointment on deputation basis shall be 56 years. The Competition Commission of India (CCI) reserves the right not to fill up the above vacancy.

3. Apart from basic pay and grade pay the post carries DA, HRA and Transport Allowance etc. as per the rates applicable to the Central Government employees from time to time. Medical reimbursement is admissible as per the CCI service rules. This is in lieu of CGHS benefits which are not admissible to the employees of CCI. The CCI is an eligible office for allotment/retention of Government Accommodation from General Pool.
