The appointment will be made on deputation on foreign service basis initially for a period of three years, except for the post of Adviser, which can be extended upto five years and will be governed by the instructions issued by the Department of Personnel and Training vide O.M. No.6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time. For the post of Adviser appointment will be made on deputation basis for a period of one year only. The maximum age limit for appointment on deputation basis shall be 56 years. The Competition Commission of India (CCI) reserves the right not to fill up any or all the above vacancies.
- 3. Apart from basic pay and grade pay, the post carries DA, HRA and Transport Allowance etc. as per the rates applicable to the Central Government employees from time to time. Medical reimbursement is admissible as per the CCI service rules. This is in lieu of CGHS benefits which are not admissible to the employees of CCI. The CCI is an eligible office for allotment/retention of Government Accommodation from General Pool.
