Engagement of Expert (Forensic Audit) in the Competition Commission of India on contract basis.

They will assist the Commission in discharge of its functions under the Competition Act, 2002 and undertake such work/tasks as may be assigned to them from time to time.

The selection will be held on the basis of experience, educational qualifications and interaction during his/her interview.
