**Note 1:** Interview letters indicating the date & time to all the above provisionally qualified candidates will be issued in due course. The candidates are, however, requested to bring the original certificates in support of their claim for date of birth, reserved category, educational/professional qualifications and relevant experience, at the time of interview. The certificates will be returned to the candidates after verification.

**Note 2:** A candidate who claims to belong to one of the Other Backward Classes should bring original certificate in the prescribed form issued by the competent authority specified by the Govt. in their O.M. No. 36012/22/93-Estt. (SC) dated 22.10.93. OBC certificate should have been issued not earlier than one year of the date of determining the eligibility i.e. not earlier than 01.01.2012. Candidate seeking reservation in OBC category has to submit a declaration in the prescribed format that he/she does not belong to the creamy layer as on last date for submission of the application, in addition to the community certificate (OBC). This was earlier indicated in the 'Invitation of Application for Direct Recruitment for various posts in the CCI', published on the website of the CCI on 04.01.2013.

**Note 3:** As per Hon'ble Supreme Court of India order dated 28.09.2012 in Petition for Special Leave to Appeal (Civil) No.34427/2011 with SLP(C) No.6988/2012 and SLP(C) No.9556/2012, "Appointment, if any, in the meantime, to the post of Deputy Director / Joint Director (Law) shall abide by the final result in these special leave petitions." Therefore, appointment to the post of Deputy Director (Law) shall be subject to this.
